**WAKEFIELD TAYLOR COURTHOUSE:  
SERVICE RELOCATION ON SEPTEMBER 2, 2025**

On Tuesday, September 2, 2025, the Wakefield Taylor Courthouse at 725 Court St. in Martinez will be closed and services relocated for the day to enable an electrical services changeover. The Wakefield Taylor Courthouse will reopen on Wednesday, September 3, 2025. The Court will place signage at all involved courthouses to assist the public in finding departments and Court services.

**Court Services (Clerk's Offices/Court Administration/Probate Examiners)**

Court services, including clerk's offices, will move to the first floor of the **Family Law Center** at 751 Pine St., Martinez, at the following windows/rooms:

- Civil/Probate filings – Windows 5 and 6.
- Civil Ex-Partes – Window 12.
- Probate Examiners – Room 144A.
- Appeals – Window 9.
- Criminal – Window 9.
- Court Administration – Window 12.

**Departments**

The following departments will move to the **Richmond Courthouse** at 100 37<sup>th</sup> St., Richmond:
