Grand Jury Report No. 1615, "Truancy and Chronic Absence in Contra Costa Schools"**

FINDINGS

Grand Jury Finding F11

The City does not have a daytime curfew.

City Response: If speaking specifically about the City of Brentwood, the City agrees with the finding.

Grand Jury Finding F12

The City that has and enforces a daytime curfew sees less daytime and juvenile crime.

City Response: The City partially disagrees with this finding. Outside of some anecdotal statements from a few police agencies that have a daytime curfew ordinance, the City is not aware of any independent research that provides factual data to support the statement that cities with daytime curfews see less daytime and juvenile crime. Therefore, the City cannot fully agree or disagree with the finding.

RECOMMENDATIONS

Grand Jury Recommendation R17

The City should consider adopting a policy to promulgate, enforce, and promote a daytime curfew.

City Response: The recommendation has been implemented. The City of Brentwood recently considered adopting a daytime curfew ordinance. After conducting research into the feasibility of a daytime curfew, it was determined that the City of Brentwood was not a good candidate for a daytime curfew. The City of Brentwood has an excellent working relationship with the Brentwood school districts, and we work closely with the schools to help address truancy. We are proud of the work we do to help identify and assist youth at risk, and we will continue to work in partnership with our school districts to find ways to decrease both truancy and juvenile crime.
